- Applicant must provide own sound or work from our small sound system.
- Stage space is NOT available. Performance will be held on the dance floor/grass area in front of stage only.
- Performers will not be compensated.
- Event is held rain or shine.
- Applicant agrees to allow the District to take photos of your performance at the Event, for no additional compensation. Photos taken may be used in CSD promotions.
